## **Percuil River Moorings Limited**

### ***The Waiting List for Moorings***

Moorings that become available for distribution are allocated by following the procedure set out below, and in accordance with the Company's Mooring Licence Conditions.

Application Forms and the Company's Mooring Licence Conditions are available at [www.percuilriver.co.uk](http://www.percuilriver.co.uk) or from the Company Secretary at the Company address.

#### **1. Who Can Apply?**

Waiting list applications will be accepted from anyone who is not currently a licensee, co-licensee, or co-habiting family of either, and also from those who as licensees, co-licensees or co-habiting family of either, do not, at the time of application, have an interest in more than one mooring in the Percuil River.

Sub-licensees renting a mooring either privately or through a boatyard are not considered as having an interest in any mooring in the Percuil River for the purposes of this condition.

#### **2. How to Apply**

Applications are to be made on the form provided by the Company, and are to be accompanied by the registration fee of £30. The registration fee will be refunded if an applicant wishes to be removed from the waiting list before being allocated a mooring.

The information required on the form includes the licensed length of the mooring applied for. This may be within a range of three feet, where the boat length is the measurement from the stemhead fitting to the aft-most extremity, including all fittings and any raised outboard. It does not include the bowsprit.

#### **3. Waiting List**

Applicants will be added to the bottom of the list as their forms are received by the Company. When a mooring becomes available, priority is given to applicants with their main residence in the TR2 postal area who do not hold a current licence or who are prepared to hand back a mooring in which they have an interest. After that, those who already have a mooring licence or have their main residence outside the TR2 postal area are considered. Nonetheless the Directors of PRML reserve the right to prioritise the allocation of any available mooring in any way they consider fit.

#### **4. Offer of a Re-distributed Mooring to a Waiting List Applicant**

Before a mooring may be used by a new licensee:

- i) the licence fee must be paid to the Company;
- ii) the registration fee must have been paid;
- iii) the payment for the mooring tackle must be paid at the rate stated in 4 k) ii) of the Licence Conditions.

Tackle payments are based on a standard formula of £1000 for a 30 foot mooring, less £20 per foot for every foot the mooring is below 30 feet or, plus £25 per foot for every foot the mooring is over 30 feet.

- iv) The mooring must have been checked as stated in 4)f)iv) of the Licence Conditions. If a mooring is allocated which has already been serviced, a contribution to the cost of servicing of up to £250 may be charged.

All re-allocated moorings will be designated as Class 'S' (Standard Licence) moorings and must be used for at least 10 weeks in a Licence year by the licensee for their own boat or the licence will not be renewed.

A boat that is not more than 3 feet less than the authorised length of the mooring must be placed on the mooring within 12 months of the mooring being allocated. If there is a change to a shorter boat at any time, the Licensee

may be allocated a suitable mooring for the shorter length.

If a Standard Licence mooring is allocated which has an authorised length greater than 2-3ft of the boat length which the applicant intends to put on it and had applied for, the Company reserves the right to move the applicant to a mooring of more suitable length when one becomes available. The second mooring would still meet the criteria for depth and location that the applicant requested. This is so the needs of the waiting list can be better fulfilled and the few 'S' moorings which are available can be better utilised. The transfer of the tackle would be carried out as explained in 4) k) of the Mooring Licence Conditions. A payment for tackle to cover the reduction in authorised length will be made and the applicant will take over the tackle on the next mooring.

The mooring may be used by a Sub-Licensee for no more than one year with permission from the Company.

The mooring is handed back to the Company when the licensee no longer has a boat for the mooring and receives a payment for the tackle as stated in 4)k) of the Licence Conditions.

If these regulations are not adhered to then the mooring will revert to the Company and there will be no refund of the registration fee. A new application may be made but no priority will be given.

If the offer of a mooring is not accepted, the application will remain in its place, if required by the applicant.

## **5. Exchange of Moorings**

Should a licensee wish to change to a longer or shorter boat they will need to apply through the waiting list for a suitable mooring. If PRML is able to effect a satisfactory exchange the licensee would be allocated an 'S' mooring and his 'A' mooring would be managed by PRML for the duration of the 'S' mooring use.

Anyone wishing to reduce the size of their mooring may use their existing mooring until such time as one of the required length becomes available.

Further details on the exchange of moorings is as follows:

### **When taking an S mooring and returning an A mooring in exchange:**

The licensee is bound by the Licence Conditions relating to 'S' moorings when using the allocated 'S' mooring.

The returned 'A' mooring will be managed by PRML for the duration of the 'S' mooring use. It will become an 'S' mooring during this time and be allocated to a waiting list applicant

The mooring tackle will be transferred as detailed in 4) k) of the Mooring Licence Conditions between the former and new licensees and with the value of the tackle of the returned 'A' mooring being netted off against the value of the allocated 'S' mooring tackle.

When the Licensee who has done an exchange has finished using the 'S' mooring and returns it to the Company, they are entitled to have an 'A' mooring back if they wish. A payment for the netted off figure for the mooring tackle would be made as detailed above.

If the Licensee does want a mooring back, if possible they will be given their original 'A' mooring back, as an 'A' mooring, but if this is not easily available, then the Company will try to find a mooring approximately equivalent to the one they gave up in exchange. If one is not available in the short term, they may, by agreement with the Company, continue to use the 'S' mooring until a suitable 'A' mooring is available or come to another arrangement with the Company.

## **6. Loan Moorings**

Licence Class A moorings which are not needed temporarily by the Licensee may be loaned back to the Company for an agreed period of time, and will be allocated to a waiting list applicant. Further details can be found at <http://www.percuilriver.co.uk/loan-moorings> or by contacting the Company.
